

Bylaw No. 15. 1906

A Bylaw to assess and levy rates or Taxes for, County Township and general and Public School purposes

Therefore be it enacted by the Municipal Corporation of the Township of Westmeath in the County of Renfrew That the following sums be levied and collected on and from all the rateable property in the Township of Westmeath for the year 1906

County

1<sup>st</sup>. The sum of \$2458<sup>28</sup>/<sub>100</sub> is hereby levied upon and shall be collected from all the rateable property in the said Township of Westmeath for County purposes for the year 1906 by a rate of 13<sup>5</sup>/<sub>8</sub> mills on the dollar

Township

2<sup>nd</sup>. The sum of \$ is hereby levied upon and shall be collected from all the rateable property in the Township of Westmeath for Township purposes for the year 1906 by the rate of 1<sup>1</sup>/<sub>2</sub> mills on the \$

Gen. rate

3<sup>rd</sup> The sum of \$2300<sup>00</sup> is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for General School purposes for the year 1906 by a rate of 13<sup>5</sup>/<sub>8</sub> mills on the \$

4<sup>th</sup> And it is further enacted That the following sums shall be levied upon and collected from all the rateable property in the said Township of Westmeath included within the limits of the several school sections hereinafter mentioned respectively for the year 1906
