

Bylaw No. 19. 1906

A Bylaw to repeal Bylaw No. 15. passed
The 18th day of August-1906 and to assess
and levy rates or taxes for County, Township
General and Public School purposes

Therefore be it enacted by the Municipal
Corporation of the Township of Westmeath
in the County of Renfrew, That Bylaw No. 15
passed the 18th day of August-1906 be repealed
and That the following sums be levied
and collected on and from all the
rateable property in the Township of Westmeath
for the year 1906

County

1st. The sum of \$2458 ⁷⁸/₁₀₀ is hereby levied
upon and shall be collected from all
the rateable property in the said Township
of Westmeath for County purposes for the year
1906 by a rate of $1\frac{3}{5}$ mills on the \$

Twp.

2nd. The sum of \$1735⁰⁰ is hereby levied
upon and shall be collected from all the
rateable property in the Township of Westmeath
for Township purposes for the year 1906 by
the rate of 1 mill on the \$

Gen. School

3rd That the sum of \$4600⁰⁰ is hereby
levied and collected from all the rateable
property of the Township of Westmeath for
General School purposes for the year 1906
by a rate of $2\frac{3}{5}$ mills on the \$

4th And it is further enacted that the
following sums shall be levied upon
and collected from all the rateable property
in the said Township of Westmeath included
within the limits of the several School

funds on or before the 31st day of December
1906 by the collector of rates for the said
Township of Westmeath in as far as the
law will enable him to do so
