A Bylaw to assess and levy rates and  
Taxes for County, Township and general  
& public School purposes

Therefore be it enacted by the Municipal  
Corporation of the Township of Westmeath  
in the County of Renfrew, That the following  
sums be levied and collected on and from  
all the rateable property in the Township of  
Westmeath for the year 1907
