

Bylaw No 39

A Bylaw to assess and levy rates and taxes for County, Township, General and Public School purposes

Therefore, be it enacted by the Municipal Council of the Corporation of the Township of Westmeath in the County of Kennew. That the following sums be levied and collected on, and from all rateable property in the Township of Westmeath for the year A.D. 1910

1st The sum of \$2971.31 is hereby levied upon and shall be collected from all the rateable property in the said Township for County purposes for the year 1910 by a rate of 1.72 mills on the dollar

2nd That the sum of \$ is hereby levied upon and shall be collected from all the rateable property in the said Township for Township purposes for the year 1910 by a rate of 1.02 mills on the dollar

3rd That the sum of \$4950 is hereby levied and shall be collected from all the rateable property in the said Township at a rate of 2.86 mills on the dollar for General School purposes

4th and it further enacted that the following sums shall be levied upon and shall be collected from all the taxable property in the said Township of Westmeath, included within the limits of the several school sections hereinafter mentioned respectively for the year 1910

And it is further enacted that the following sums shall be levied and collected from all the taxable property within the limits of School Section number 2 in the said Township

of paying School debentures for the year
A.D. 1910 at a rate of three and one half
mills on the dollar.

imposed by this Bylaw, shall be collected and
paid over to the Treasurer of the corporation
of the said Township of Westmeath on or
before the 31st day of December A.D.
1910, by the collector of Rates and taxes in
as far as the law will enable him to
do so. Passed in open Council
