- 1.....THAT Public School Section Number 5 of the Township of  
Bromley be dissolved -
- 2.....THAT Lots 16,17,18,19,20 and 21 in the First Concession  
and Lots 16 and 17 and parts of Lots 20 and 21 in the  
Second Concession of the Township of Bromley in said  
Section 5 be joined to the Union School Section at the  
Village of Cobden -
- 3.....THAT lots 22,23,24, and 25 in the First Concession and  
Lots 22,23,24,25 and 26 in the Second Concession of the  
Township of Bromley in said Section 5 be joined to Union  
School Section Number Eleven between portions of the Town-  
ships of Bromley and Westmeath -
- 4.....THAT that portion of Lot 26 in the Third Concession of  
the Township of Bromley being within said Section 5 be  
joined to Union School Section Number one between  
portions of the Townships of Stafford and Bromley -
- 5.....THAT all of the above mentioned School Sections, Union or  
Non-Union, be altered or dissolved as the case may be as  
may be required to carry into effect the prayer of this  
Petition or so much thereof as may appear proper -
- 6.....THAT in the alternative such provision be made, such alter-  
ations made in said Sections, such lots or parts or lots  
in the said Municipalities respectively be separated from  
or joined to such School Sections or Section, Union or  
Non-Union as may be reasonable and proper under the cir-  
-cumstances for the convenience of those Ratepayers  
interested.

7.....THAT your honourable bodies respectively take such steps as may be necessary under Section 21 and other Sections of "The Public Schools Act", 9 Edw. VII, C.89, to effect the above.
