

Bylaw No 60 1911

A Bylaw to assess and levy rates and taxes for County, Township, General, and Public School purposes

Therefore be it enacted by the Municipal Council of the Corporation of the Township of Westmeath in the County of Kennew. That the following sums be levied and collected on and from all rateable property in the Township of Westmeath for the year A.D. 1911

1st The sum of \$3245.88 is hereby levied upon and shall be collected from all the rateable property in the said Township for County purposes for the year 1911 by a rate of 1.87 mills on the dollar

2nd That the sum of \$1677.34 is hereby levied upon and shall be collected from all the rateable property in the said Township for Township purposes for the year 1911 at a rate of .96 of one mill on the dollar

3rd That the sum of \$5158.78 is hereby levied upon and shall be collected from all the rateable property in the said Township at a rate of 2.97 mills on the dollar for General School purposes

4th and it is further enacted that the following sums shall be levied upon and shall be collected from all the rateable property in the said Township of Westmeath included within the limits of the several schools

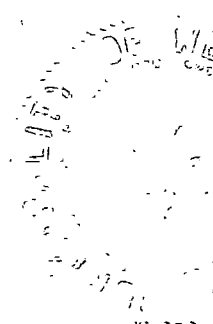

 property within the limits of
 School Section number two in the
 said Township of Westmeath for
 the purpose of paying school
 Debentures for the year 1911 at
 a rate of $3\frac{1}{2}$ mills on the dollar
 and it is further enacted that the
 rates imposed by this Bylaw, shall
 be collected and paid over to the
 Treasurer of the Corporation of the said
 Township of Westmeath on or before
 the 30th day of December A.D. 1911 by the
 Collector of Rates and taxes in as far
 as the Law will enable him to do
 so. Passed in open Council this
 fifteenth day of August 1911
