

Bylaw No 105 1913

A Bylaw to assess and Levy rates and taxes for County, Township, General and Public School purposes

Therefore be it enacted by the Municipal Council, of the Corporation of the Township of Westmeath in the County of Kuyhew

That the following sums be levied on and collected from all ratable property in the Township of Westmeath for the year A.D. 1913

1/ That the sum of \$3512.83 is hereby levied upon and shall be collected from all the ratable property in the said Township for County purposes for the year 1913 at a rate of 2.06 Mills on the dollars

2/ That the sum of \$1626.21 is hereby levied upon and shall be collected from all the ratable property in the said Township at a rate of .93 of one mill on the dollar for Township purposes for the year 1913

3/ That the sum of \$4994.00 is hereby levied upon and shall be collected from all the ratable property in the said Township for General School purposes at a 2.86 Mills on the dollar for the year 1913

4/ And it is further enacted that the following sums shall be levied upon and collected from all the ratable property in the said Township in divided within the limits of the several school sections hereinafter mentioned respectively, for the year 1913

And it is further enacted that the sum of \$691⁸⁸ shall be levied upon and collected from all the taxable property within the limits of school section no 2 in the said Township of Westmeath for the purpose of paying school debentures for the year 1913 at a rate of 3 $\frac{6}{10}$ Mills on the dollar

And it is further enacted that the rates imposed by this Bylaw, shall be collected and paid over to the Treasurer of the Corporation of the Township of Westmeath on or before the thirty first day of December A.D. 1913 by the collector of Rates and taxes in so far as the law will enable him to so do
