

Bylaw No 189 1917

a Bylaw to assess and levy rates and taxes for war, County, Township General, Public and separate school purposes for the year 1917

Therefore be it enacted by the Municipal Council of the Corporation of the Township of Westmeath in the County of Renfrew

That the following sums be levied on and collected from all the ratable property in the Township of Westmeath for the year 1917.

1/ That the sum of \$1928⁰⁰ is hereby levied upon and shall be collected from all the ratable property in the said Township of Westmeath for war purposes for the year 1917 at a rate of 1.06 Mills on the dollar

2/ That the sum of \$6940.⁸⁰ is hereby levied upon and shall be collected from all the ratable property in the said Township of Westmeath for County and County Equivalent for school purposes for the year 1917 at a rate of 3.93 Mills on the dollar

3/ That the sum of \$1959.⁸³ is hereby levied upon and shall be collected from all the ratable property in the said Township of Westmeath for Township purposes for the year 1917 at a rate of 1.08 Mills on the dollar

4/ That the sum of \$5451.⁸⁰ be and is hereby levied upon all the ratable property in the Township of for General School purposes for the year 1917 at a rate of 3.13 Mills on the dollar
