

Bylaw No 212 - 1918

A Bylaw to assess and levy rates and taxes for County Road, War, Township General School, Public and separate school purposes.

Therefore be it enacted by the Municipal Council of the Corporation of the Township of Westmeath in the County of Kenora:

That the following sums and rates be levied upon and collected from all rates in the Township of Westmeath for the year A.D. 1918:

1/ That the sum of \$8848.⁰⁰ is hereby levied upon and shall be collected from all the rateable property in the said Township for County and County Equivalent purposes for the year 1918 at a rate of 4.86 Mills on the Dollar.

2/ That the sum of \$1930.⁰⁰ is hereby levied upon and shall be collected from all the rateable property in the said Township for Provincial War purposes at a rate of 1.06 Mills on the Dollar for the year 1918.

3/ That the sum of \$2895.⁰⁰ is hereby levied upon and shall be collected from all the rateable property in the said Township for County Road purposes for the year 1918 at a rate of 1.58 Mills on the Dollar.

4 That the sum of \$1644⁰⁰ is hereby levied upon and shall be collected from all taxable property in the said Township for Township purposes for the year 1918 at a rate of $\frac{9}{10}$ of 1 mill on the dollar

5 That the sum of \$5552.00 is hereby levied upon and shall be collected, all the taxable property in the said Township liable for Public School purposes for General School purposes for the year 1918 at a rate of $\frac{31}{100}$ mills on the dollar

6 And it is further enacted that the following rates shall be levied upon and collected from all the taxable property in the said Township included within the limits of the several school sections hereinafter mentioned respectively for the year 1918

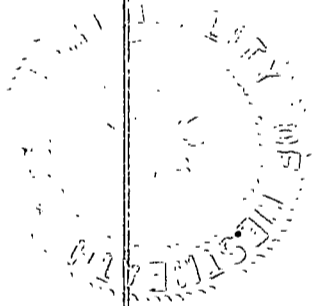
