

A By-law to assess and levy rates and taxes for County, Township General and Public School Purposes for the year 1920.

Whereas it is necessary to pass a by-law to assess and levy rates and taxes for County, Township, General and Public School purposes.

Therefore be it enacted by the Municipal Council of the Corporation of the Township of Westmeath in the County of Renfrew

That the following sums be levied on and collected from all the rateable property in the Township of Westmeath for the year 1920

- I That the sum of \$15,440⁰⁰ is hereby levied upon and shall be collected from all the rateable property in the said Township of Westmeath for County purposes for the year 1920 at a rate of 8.4 mills on the \$1.
- II That the sum of \$25,74⁰⁰ is hereby levied upon and shall be collected from all the rateable property in the said Township of Westmeath at a rate of 1.4 mills on the \$1. for Township purposes for the year 1920
- III That the sum of \$10,900⁰⁰ be and is hereby levied upon and shall be collected from all the rateable property of Public School supporters in the said Township of Westmeath for General School purposes at a rate of 6.2 mills on the \$1. for the year 1920.
- IV And it is further enacted that the following rates on the dollar

shall be levied upon and collected from all the rateable property in the said Township of Westmeath included within the limits of the several School Sections hereinafter mentioned respectively for the year 1920
