

Bylaw No. —

A. By-law to appoint Road Commissioners for the Township of Westmeach and to apportion the amount to be expended by each in their several divisions, which shall not be exceeded by them except to build bridges which may cost over Fifty-dollars each.

Whereas it is necessary to pass a by-law for the appointment of road Commissioners and to limit the amount of their expenditure for the current year.

Therefore be it enacted by the municipal Council of the Corporation of the Township of Westmeach as follows:—

That Jas. D. McLean of the Township of Westmeach be and is hereby appointed Road Commissioner for Road Div # 1. and the amount he be authorized to expend \$1200<sup>00</sup>

That Wm Baird of the Township of Westmeach be and is hereby appointed Road Commissioner for Road Div # 2. and the amount he be authorized to expend \$1065<sup>00</sup>

That Lorne Dunn of the Township of Westmeach be and is hereby appointed Road Commissioner for Road Div # 3. and the amount he be authorized to expend \$840
