Y-LAW No. 8 cm A By-Law of the Municipality of entitled a By-law to authorize the construction and improvement of roads within the said Municipality in the year 1925 Wibereas under the Colonization Roads Act, Chap. 41, R.S.O. 1914, as amended by Chap. 17: 4, and Chap. 25: 10-11 Geo. And Whereas it is desired to construct and improve certain roads in the Municipality of Mediane being one of such Municipalities described in the Act, by clearing, grading, draining, gravelling or other work of a substantial and permanent character, over and above the ordinary stature labour, in the said Municipality, at the total estimated cost of the sum of \_\_\_\_\_dollars ;

And Wibereas under the authority of the "Municipal Act of Ontario," the power is given to Municipalities to assess and levy a rate or otherwise provide a sufficient sum to defray the cost of road construction and improvement within the Municipality;
