A BY-LAW TO APPOINT FIVE DEPUTY RETURNING OFFICERS TO HOLD ELECTIONS FOR THE MEMBERS OF THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WESTMEATH FOR THE YEAR 1926 AND TO ESTABLISH THE PLACE FOR HOLDING THE NOMINATION AND POLLING AT THE SAID ELECTION.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WESTMEATH ENACTS AS FOLLOWS;

- 1st: THAT THE NOMINATION OF CANDIDATES FOR THE MUNICIPAL COUNCIL OF THE SAID TOWNSHIP OF WESTMEATH BE HELD IN THE TOWN HALL, BEACHBURG.
- 2nd: THAT. O CHARLEDE AND IS HEREBY APPOINTED DEPUTY RETURNING OFFICER AT SAID ELECTION FOR POLITING SUB-DIVISION #1 AND THAT THE TOWN HALL, BEACHBURG BE THE POLLING PLACE FOR THE SAID ELECTORAL DIVISION.
- 3rd: THATO, OF THE TOWNSHIP OF WESTMEATH BE AND IS HEREBY APPOINTED DEPUTY RETURNING OFFICER FOR POLITING SUB-DIVISION #2 AND THAT MOORES SCHOOL HOUSE BE THE POLITING PLACE FOR THE SAID ELECTORAL DIVISION.
- 4th: THAT. OF THE TOWNSHIP OF WESTMEATH BE AND IS HEREBY APPOINTED DEPUTY RETURNING OFFICER FOR POLLING SUB-DIVISION #3 AND THAT THE PUBLIC HALL, WESTMEATH BE THE POLLING PLACE FOR THE SAID ELECTORAL DIVISION.
- 5th: THAT OF THE TOWNSHIP OF WESTMEATH BE AND IS HEREBY APPOINTED DEPUTY RETURNING OFFICER FOR POLLING SUB-DIVISION #4 AND THAT LEE'S SCHOOL HOUSE BE THE POLLING PLACE FOR THE SAID ELECTORAL DIVISION.
- 6th: THAT LOYAL CETAL OF THE TOWNSHIP OF WESTMEATH BE AND IS HEREBY APPOINTED DEPUTY RETURNING OFFICER FOR POLLING SUB-DIVISION #5 AND THAT THE SEPARATE SCHOOL HOUSE BASEMENT BE THE POLLING PLACE FOR THE SAID ELECTORAL DIVISION.
