By-Law No 8

2. That this By-law, after the second reading thereof in Council, be submitted to the Minister charged with the administration of the Department of Northern Development, who may approve, alter or modify it, and upon its being amended in accordance with the aforesaid approval, alteration or modification of the said Minister, and finally passed by the Council of the said Municipality, it shall be forwarded to the Department of Northern Development to be kept by them.

3. That the sum of ~~Six Thousand~~ ^{3250.⁰⁰} ~~SEXTY~~ ^{Five Hundred} dollars shall be raised locally by the said Municipality for the purpose of defraying the proportion of the cost of road construction and improvement to be borne by them under this By-law.
