In answer to your letter of the 19th instant, we would suggest that you have the Insured accept the enclosed Reinstatement Endorsement. This will take care of his insurance until July 22nd, and if at that time he decided to replace the insurance the Pro Rata refund shown on the Endorsement would be deducted from the annual premium under the new Policy. If, however, he is still of the same mind as at present, a Short Rate refund would be paid to him. We think that this would be a much better way of handling the matter than issue a new Policy for a short period, as there is always a chance that by the middle of July the Insured will change his mind and continue to place his insurance through you with us.

Dear Mr. McLean, -

With regard to By-Law No. 16 of the Township of Westmeath I may say that I am afraid that there was no power in the Municipality to pass that By-Law. The By-Law purports to be passed in pursuance of Section 253 of Chapter 72 of R.S.O. 1922. As there was no revision of the Statutes in 1922 I presume that what is meant is Section 253 of Chapter 72 of the Statutes of 1922. This Act is a consolidation of the Municipal Act and amendments up to 1922. The Section referred to does not give the power to pass such a By-Law. The only thing the Section gives is the power to prohibit the carrying on or engaging in any trade, calling, business or occupation without a license where the Municipality has power to license any such trade, calling, business or occupation, and the Section does not confer on Municipalities any power to license.

The only Section of the Municipal Act which deals with the licensing of drivers of automobiles or other vehicles for hire and the regulating of the charges for services rendered and for licensing keepers of livery stables and of horses, cabs and vehicles used

or kept for hire and regulating the fees to be charged for the conveyance of goods and passengers is Section 408. of the Municipal Act R.S.O. 1927, Chapter 233. This Section was formerly Section 407 of Chapter 72 of the Statutes of 1922. By it the power to license and to regulate is given only to the councils of Towns and Villages. No powers such as are by that Section given to the councils of Towns and Villages are given anywhere in the Act to the councils of Townships.

My opinion therefore is that the By-Law is invalid and cannot be acted upon by the Municipality.

My fee herein is \$3.00.
