Whereas it is necessary to pass a By-Law to assess & levy Rates and Taxes for County. Township. General & Public School purposes for the year 1931.

There-fore be it enacted by the Municipal Council of the Corporation of the Township of Westmeath as follows:That the following Sums be levied on & Collected from all the
Rateable property in the Township of Westmeath as for the year 1931.

- lst That the Sum of \$40,795. The is hereby levied upon \$shall be collected from all rateable property in the Township of Westmeath for County purposes for the year 1931 at a Rate of 22 mills on the dollar.
- Ind That the sum of \$4.079.51 is hereby levied upon & shall be collected from all rateable property in the said Township of Westmeath at the Rate of 2.2 mills on the dollar for Nownship purposes for the year 1931.
- That teh sum of \$11.900.04 be & is hereby levied upon & shall be collected from all the rateable property of Public School supporters in said Township of Westmeath for General School purposes at the Rate of 6.7 mills on the dollar for the year 1931.
- And be it further enacted that the following rates on the dollar shall be levied upon & collected from all rateable property in the Township of Westmeath included within the Limits of the several School Sections herein after mentioned respectively for the year 1931.
