

A BY-LAW TO ASSESS AND LEVY RATES AND TAXES FOR COUNTY TOWNSHIP AND GENERAL AND PUBLIC SCHOOL PURPOSES FOR THE YEAR 1932.

Whereas it is necessary to pass a BY-LAW to assess & levy RATES and TAXES for COUNTY, TOWNSHIP, GENERAL & PUBLIC School purposes for the year 1932.

Therefore be it enacted by the Municipal Council of the Corporation of the Township of Westmeath as follows:-

That the following sums be levied on and Collected from all the Rateable property in the TOWNSHIP of WESTMEATH as for the year 1932.

- 1st That the SUM of \$40,714.19 is hereby levied upon and shall be collected from all rateable property in the TOWNSHIP of WESTMEATH for COUNTY PURPOSES for the year 1932 at a RATE of 22.1 mills on the dollar.
- 2nd That the sum of 3,500.00 is hereby levied upon and shall be collected from all rateable property in the TOWNSHIP of WESTMEATH at the RATE of 2.1 mills on the dollar for TOWNSHIP PURPOSES for the year 1932.
- 3rd That the sum of \$11,900.00 is hereby levied upon and shall be collected from all the rateable property of PUBLIC SCHOOL supporters in said TOWNSHIP of WESTMEATH for GENERAL SCHOOL PURPOSES at the RATE of 6.8 mills on the dollar for the year 1932.
- 4th And be it further enacted that the following RATES on the Dollar shall be levied upon and collected from all rateable property in the TOWNSHIP of WESTMEATH included within the LIMITS of the several SCHOOL SECTIONS herein -after mentioned respectively for the year 1932.
