A BYLAW TO ASSESS AND LEVY RATES AND TAXES FOR COUNTY, TOWNSHIP, GENERAL AND PUBLIC SCHOOL PURPOSES FOR YEAR 1936

Whereas it is necessary and expedient to pass a BYLAW to assess and levy rates and taxes for Township, County, General, and Public School purposes for the year 1936

Therefore be it now enacted by the Municipal Council of the Corporation of The Township of Westmeath as follows: -

That the following sums be levied upon and collected from all rateable property in the Township of Westmeath for the year 19**3**6

- That the sum of \$33.249.92 is hereby levied upon and shall lst be collected from all rateable property in the Township of Westmeath for COUNTY purposes for the year 1936 at a rate of 18.3 mills on the dollar,
- 2nd That the sum of \$1.817.48 is hereby levied upon and shall be collected from all the rateable property within the Township of Westmeath for Township purposes for the year 1936 at a rate of 1,0 mill on the dollar,
- That the sum of \$9.520.00 is hereby levied upon and shall be 3rd collected from all the rateable property of Public School supporters in the said Township for General School Purposes for the year 1936 at a rate of 5.5 mills on the dollar,
- And it is further enacted that the following rates on the 4th dollar shall be levied upon and collected from all rateable property in the said Township included within their limits of the several school sections hereinafter mentioned respectively for the year 1936
