

A BYLAW TO ASSESS AND LEVY RATES AND TAXES FOR COUNTY, TOWNSHIP, GENERAL, & PUBLIC SCHOOL PURPOSES FOR THE YEAR 1937 $\frac{1}{2}$

Whereas it is necessary and expedient to provide by BYLAW to assess and levy rates and taxes for Township, County, General, and School purposes for the year 1937, *also Street-Lights*

Therefore be it now enacted by the Municipal Council of the Corporation of the Township of Westmeath as follows:-

That the following sums be levied upon and collected from all rateable property in the Township of Westmeath for the year 1937,

1st That the sum of \$24,428.52 is hereby levied upon and shall be collected from all rateable property within the Township of Westmeath for COUNTY purposes for the year 1937 at a rate of 13.5 mills on the dollar,

2nd That the sum of \$3,507.20 is hereby levied upon and shall be collected from all rateable property within the Township excepting those in School Sections Nos 2 and 7 at a rate of 2.6 mills on the dollar, for the year 1937,

3rd That the sum of \$1,810.50 is hereby levied upon and shall be collected from all the rateable property within the Township for Township purposes, for the year 1937 at a rate of 1.0 mill on the dollar,

4th That the sum of \$9,520.00 is hereby levied upon and shall be collected from all rateable property of Public School supporters in the said Township for General School Purposes for the year 1937, at a rate of 5.5 mills on the dollar,

5th And be it further enacted that the following rates on the dollar shall be levied upon and collected from all rateable property in the said Township included within their limits of the several School Sections herein after mentioned respectively for year 1937

And further be it enacted that the sum of \$144.00 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the Hamlet of Westmeath for the purpose of STREET LIGHTING at a rate of 2.3 mills on the dollar,
