

A BYLAW TO ASSESS AND LEVY RATES AND TAXES FOR COUNTY, TOWNSHIP, GENERAL, & PUBLIC SCHOOL PURPOSES, AND STREET LIGHTS INCLUDING EDUCATIONAL RATES AND DEBENTURES FOR THE YEAR 1938.

Whereas it is necessary and expedient to provide by BYLAW to assess and levy rates and taxes for County, Township, General, and Public School purposes including Educational and Street Lights for the year 1938,

Therefore be it now enacted by The Municipal Council of The Corporation of the Township of Westmeath as follows.

That the following sums be levied upon and collected from all rateable property in the Township of Westmeath for the year 1938

- 1st That the sum of <sup>23,093.38</sup> \$23,093.38 is hereby levied upon and shall be collected from all rateable property within the Township of Westmeath for County purposes for the year 1938 at a rate of 12.7 mills on the dollar,
- 2nd That the sum of \$1,818.37 is hereby levied upon and shall be collected from all rateable property within the Township for Township purposes for the year 1938 at a rate of 1.0 on the \$.
- 3rd That the sum of \$2,217.63 is hereby levied upon and shall be collected from all rateable property within the Township of Westmeath excepting those in school sections Nos 2 & 7 for Educational purposes for the year 1938 at a rate of 1.7 mills on the dollar,
- 4th That the sum of \$ 10,846.44 is hereby levied upon and shall be collected from all rateable property of Public School supporters in the said Township of Westmeath for General School Purposes for the year 1938 at a rate of 6.2 mills on the dollar,
- 5th That the sum of \$273.60 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the Hamlet of Beachburg for the purpose of Street Lighting for the year 1938 at a rate of 2.0 mills on the dollar,
- 6th That the sum of \$144.00 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the Hamlet of Westmeath for the purposes of Street lighting for the year 1938 at a rate of 2.3 mills on the dollar,
- 7th And be it further enacted that the following rates on the dollar shall be levied upon and collected from all rateable property in the said Township included within thier limits of the several School Sections hereinafter mentioned respectively for the year 1938,
