A BYLAW TO ASSESS AND LEVY RATES AND TAXES FOR COUNTY, TOWNSHIP, GENERALS CHOOL, PUBLIC SCHOOLS, STREET LIGHTS, ROADS, AND ALL OTHER PURPOSES FOR THE YEAR 1939,

Whereas it is necessary and expedient to provide by By-Law to assess and levy rates and taxes for the purposes above mentioned, Therefore be it now enacted by the Municipal Council of the Corporation of the Township of Westmeath as follows:-

That the following sums be levied upon and shall be collected from all the rajeable property within the Township of Westmeath for the year 1939,

- 1st That the sum of \$22.545.40 is hereby levied upon and shall be collected from all reteable property within the Township of Westmeath for County Purposes for the year 1939 at a rate of 12.4 mills on the dollar,
- 2nd That the sum of \$3.018.87 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath excepting those in School Sections No 2 and 7 at a rate of 2.2 mills on the dollar for the purpose of County Pupils for the year 1939,
- 3rd That the sum of \$1.818.17 is hereby levied upon and shall be collected from all the rateable property in the Township of Westmeath for Township Purposes for the year 1939 at a rate of 1.0 mill on the dollar,
- 4th That the sum of \$10.848.61 is hereby levied upon and shall be collected from all rateable property of Public School supporters in the said Township for General School Purposes for the year 1939 at a rate of 6.2 mills on the dollar,
- 5th That the sum of \$3.636.35 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for ROAD Purposes for the year 1939 at a rate of 2.0 mills on the dollar.

  6th That the sum of \$304.50 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the hamlet of Beachburg for the year 1939 for the purpose of Street Lighting at the rate of 2.1 mills on the dollar,

  7th That the sum of \$153.75 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the hamlet of Westmeath for the year 1939 for the purpose of Street Lighting at the rate of 2.5 mills on the dollar,
- 8th And be it further enacted that the following rates on the dollar shall be levied upon and collected from all nateable property in the said Township included within the limits of the several School Sections hereinafter mentioned respectively for the year 1939.
