A BY-LAW TO ASSESS AND LEVY RATES AND TAXES FOR COUNTY, TOWNSHIP, GENERAL SCHOOL, PUBLIC SCHOOLS, CONTINUATION SCHOOL, ROADS, STREET LIGHTS, Etc_

Whereas it is necessary and expedient to provide by BY-LAW to assess and levy rates and taxes for the above mentioned for the year 1941,

Therefore be it now enacted by the Municipal Council of the Corporation of the Township of Westmeath as follows:

That the following sums be levied upon and shall be collected from all rateable property within the Township of Westmeath for the year 1941,

1st That the sum of \$21.035.66 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for County Purposes for the year 1941 at a rate of 11.6 mills on the dollar,

2nd That the sum of \$2.752.88 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath (excepting those in School Sections No 2 and No 7) at a rate of 2.0 mills on the dollar for County Pupils for the year 1941,

Brd That the sum of \$1.820.68 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for Township Purposes for the year 1941 at a rate of 1.0 mill on the dollar.

th That the sum of \$3.641.37 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for ROAD PURPOSES for the year 1941 at a rate of 2.0 mills on the dollar,

5th That the sum of \$1.690.03 is hereby levied upon and shall be collected from all rateable property in School Section number seven (7) for DEBENTURE PURPOSES for the year 1941 at a rate of 6.3 mills on the dollar,

6th That the sum of \$9.900.00 is hereby levied upon and shall be collected from all rateable property of PUBLIC SCHOOL SUPPORTERS in the Township of Westmeath for GENERAL SCHOOL PURPOSES for the year 1941 at a rate of 5.7 mills on the dollar,

7th That the sum of \$304.50 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the Hamlet of Beachburg for the year 1941 for the purpose of STREET LIGHTING at a rate of 2.1 mills on the dollar.

8th That the sum of \$154.00 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the Hamlet of Westmeath for the year 1941 for the purpose of STREET LIGHTING at a rate of 2.5 mills on the dollar.

9th And be it further enacted that the following rates on the dollar shall be levied upon and collected from all rateable property in the Township of Westmeath included within the limits of the several School Sections hereinafter mentioned respectively for the year 1941,
