

A BY-LAW TO PROVIDE FOR THE TOTAL 19 42 EXPENDITURE ON ROADS IN THE TOWNSHIP OF WESTMEATH IN THE COUNTY OF RENFREW

WHEREAS The Highway Improvement Act, Chapter 56, R.S.O., 1937 and amendments requires that the total expenditure on township roads and bridges be provided for annually by township by-law.

THEREFORE the council of the corporation of the said township enacts as follows:

(1) The sum of \$ 8,000.00 is hereby appropriated from monies raised by levy, debentures and government subsidy for total expenditure upon construction and maintenance of the roads in the said township during the year 1942 as follows:
