BY-LAW NUMBER 332-

A BY-LAW TO ASSESS AND LEVY RATES AND TAXES FOR COUNTY-TOWNSHIP, GENERAL SCHOOL, PUBLIC SCHOOLS, CONTINUATION SCHOOLS, ROADS, STREET LIGHTS, ETC, FOR THE YEAR 1942:-

Whereas it is necessary and expedient to provide by BY-LAW to assess and levy rates and taxes for the above mentioned items for the year 1942:-

Therefore be it now enacted by the MUNICIPAL COUNCIL of the CORPORATION of the TOWNSHIP OF WESTMEATH as follows:-

That the following sums be levied upon and shall be collected from all rateable property within the Township of Westmeath for the year 1942:-

- That the sum of \$22.721.21 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for COUNTY PURPOSES for the year 1942 at a rate of 12.5 mills on the dollar,
- 2nd That the sum of \$3.014.44 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath (excepting those in School Sections No 2 and 7) at a rate of 2.2 mills on the dollar for COUNTY PUPILS for the year 1942:-
- That the sum of \$1,817.69 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for TOWNSHIP PURPOSES for the year 1942 at a rate of 1.0 mill on the dollar,
- That the sum of \$2,544.77 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for ROAD PURPOSES for the year 1942 at a rate of 1.4 mills on the dollar,
- That the sum of \$1,689,62 is hereby levied upon and shall be collected from all rateable property in School Section number seven (7) for DEBENTURE PURPOSES for the year 1942 at a rate of 6.3 mills on the dollar,
- That the sum of \$10,520.38 is hereby levied upon and shall be collected from all rateable property of PUBLIC SCHOOL SUPPORTERS in the Township of Westmeath for GENERAL SCHOOL PURPOSES for the year 1942 at a rate of 6.0 mills on the dollar,
- 7th That the sum of \$304,50 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the hamlet of Beachburg for the year 1942 for the purpose of STREET LIGHTING at a rate of 2.1 mills on the dollar,
- 8th That the sum of \$154.00 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the hamlet of Westmeath for the year 1942 for the purpose of STREET LIGHTING at the rate of 2.5 mills on the dollar,
- And be it further enacted that the following rates on the dollar shall be levied upon and collected from all rateable property in the Township of Westmeath included within the limits of the several School Sections hereinafter mentioned respectively for the year 1942,
