BY-LAW NUMBER 366

A BY-LAW TO ASSESS AND LEVY RATES AND TAXES FOR COUNTY, TOWNSHIP, GENERAL SCHOOL, PUBLIC SCHOOLS, CONTINUATION SCHOOLS, ROADS, STREET LIGHTS, ETC, FOR THE YEAR 1943:-

Whereas it is necessary and expedient to provide by BY-LAW to assess and levy rates and taxes for the above mentioned items for the year 1943:-

Therefore be it now enacted by the Municipal Council of the Corporation of the Township of Westmeath as follows:-

That the following sums be levied upon and shall be collected from all rateable property within the Township of Westmeath for the year 1943:-

- That the sum of \$21,307.09 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for COUNTY PURPOSES for the year 1943 at a rate of 11.8 mills on the dollar,
- That the sum of \$3.563.12 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath (excepting those in School Sections No 2 and 7) for COUNTY PUPILS at a rate of 2,6 mills on the dollar for the year 1943,
- That the sum of \$1,811,85 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for TOWNSHIP PURPOSES at a rate of 1.0 on the dollar for the year 1943.
- That the sum of \$3,623,71 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for ROAD PURPOSES at a rate of 2.0 mills on the dollar for the year 1943,
- That the sum of \$1,606.38 is hereby levied upon and shall be collected from all rateable property in School Section No 7 for DEBENTURE PURPOSES at a rate of 6.0 on the dollar for the year 1943.
 - That the sum of \$10,839,19 is hereby levied upon and shall be collected from all rateable property of PUBLIC SCHOOL SUPPORTERS in the Township of Westmeath for GENERAL SCHOOL PURPOSES at a rate of 6.2 mills on the dollar for the year 1943,
- 7th That the sum of \$304,50 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the Hamlet of Beachburg for the purpose of STREET LIGHTS at a rate of 2.1 mills on the dollar for the year 1943.
- 8th That the sum of \$154.00 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the hamlet of Westmeath for the purpose of STREET LIGHTS at a rate of 2.5 mills on the dollar for the year 1943.
- And be it further enacted that the following rates on the dollar shall be levied upon and collected from all rateable property in the Township of Westmeath included within the limits of the several SCHOOL SECTIONS hereinafter mentioned for the year 1943.
