BY-LAW No\_H27-

A BY-LAW TO ASSESS AND LEVY RATES AND TAXES FOR COUNTY, TOWNSHIP, SCHOOLS, ROADS, STREET LIGHTS, GRANTS, AND ALL OTHER PURPOSES FOR THE YEAR 1945:-

Whereas it is necessary and expedient to provide by BY-LAW, for the purpose of assessing and levying rates and taxes for the year 1945 for the following purposes,

Therefore be it now enacted by the Municipal Council of the Corporation of the Township of Westmeath that the following sums be levied upon and collected from all rateable property within the Municipality of Westmeath for the year 1945:-

- 1st That the sum of \$15,569,28 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for COUNTY PURPOSES, for the year 1945, at a rate of 8,6 mills on the dollar,
- 2nd That the sum of \$2,455,68 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath (excepting those in School Sections No 2 and 7) for COUNTY PUPILS at a rate of 1,8 mills on the dollar, for the year 1945,
- 3rd That the sum of \$1,810, 38 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for Township purposes for the year 1945, at a rate of 1,0 mill on the dollar,
- 4th That the sum of \$3,620,76 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for ROAD PURPOSES, for the year 1945, at a rate of 2,0 mills on the dollar,
- 5th That the sum of \$9,603,17 is hereby levied upon and shall be collected from all rateable property of PUBLIC SCHOOL SUPPORTERS in the Township of Westmeath for General School Purposes, for the year 1945 at a rate of 5,5 mills on the dollar,
- 6th That the sum of \$304,50 is hereby levied upon and shall be collected from all rateable property within an area, known as a lighting area for the Hamlet of Beachburg for the year 1945 for the purpose of STREET LIGHTS, at a rate of 2,1 mills on the dollar,
- 7th That the sum of \$154,00 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the Hamlet of Westmeath, for the year 1945 for the purpose of STREET LIGHTS, at a rate of 2,5 mills on the dollar,
- 8th That the sum of \$3,620,76 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for the purpose of creating a fund for making grants to such persons of the Municipality (who qualify as residents) who have served in His Majestys armed forces, at a rate of 2,0 mills on the dollar, for the year 1945,
- 9th And be it further enacted that the following rates on the dollar shall be levied upon and collected from all rateable property in the Township of Westmeath included within the limits of the several School Sections hereinafter mentioned for the year 1945,
