A By-law to assess and levy rates and taxes for County, Township Schools, Roads, Street Lights, Grants, Special Rates, and all other purposes for the year 1948-

Whereas it is necessary and expedient to provide by BY-LAW for the purpose of assessing and leving rates and taxes for the year 1948 for the following purposes.

Therefore be it now enacted by the Municipal Council of the Corporation of the Township of Westmeath that the following sums be levied upon and shall be collected from all rateable property in the Municipality of Westmeath for the year 1948,

- That the sum of \$20,643,48 is hereby levied upon and shall be collected from all rateable property in the Township of Westmeath for COUNTY PURPOSES for the year 1948 at a rate of 11.4 mills on the dollar,
- 2nd That the sum of \$2,008,76 is hereby levied upon and shall be collected from all rateable property within the Township of Westmeath (excepting those in school sections No's 2-7-8-9-11) for COUNTY PUPILS for the year 1948 at a rate of 2.0 on the \$
- 3rd That the sum of \$5.444.76 is hereby levied upon and shall be collected from all rateable property within the Township of Westmeath for TOWNSHIP PURPOSES for the year 1948 at a rate of 3.0 mills on the dollar.
- That the sum of \$9.437.83 is hereby levied upon and shall be collected from all rateable property of Public School Supporters in the Township of Westmeath for GENERAL SCHOOL PURPOSES for the year 1948 at a rate of 5.4 mills on the dollar,
- That the sum of \$7.259.69 is hereby levied upon and shall be collected from all rateable property within the Township of Westmeath as a special FUND for the purpose of purchasing FIRE-FIGHTING EQUIPMENT for the Township of Westmeath at a rate of 4.0 mills on the dollar for the year 1948-
- That the sum of \$11,615,50 is hereby levied upon and shall be collected from all rateable property within the Township of Westmeath for ROAD PURPOSES for the year 1948 at a rate of 6.4 mills on the dollar,
- 7th That the sum of \$320.90 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the Hamlet of BEACHBURG for the year 1948 for the purpose of STREET LIGHTS at a rate of 2.1 mills on the \$
- 8th That the sum of \$156.56 is hereby levied upon and shall be collected from all rateable property within an area known as a lighting area for the Hamlet of WESTMEATH for the year 1948 for the purpose of STREET LIGHTS at a rate of 2.5 mills on the \$
- 9th That the sum of \$1.359.56 is hereby levied upon and shall be collected from all rateable property within School Sections No's 8--11 for the purpose of the Renfrew-Cobden and District Bigh School Board at a rate of 4.8 mills on the dollar for 1948-
- 10th That the sum of is hereby levied upon and shall be collected from all rateable property within School Section No. 9 for the purpose of Pembroks District High School Board at a rate of mills on the dollar for the year 1948-

And be it further enacted that the following rates on the dollar shall be levied upon and shall be collected from all rateable property in the Township of Westmeath included within the limits of the several School Sections hereinafter mentioned for the year 1948-
