BY-LAW NO. 578

A By-Law to assess and levy rates and taxes for County, Township, Schools, Roads, Street Lights, Grants, and all other purposes for the year 1949-

Whereas it is necessary and expedient to provide by By-Law for the purpose of assessing and leving rates and taxes for the year 1949 for for the following purposes,

Therefore be it now enacted by the Municipal Council of the Corporation of the Township of Westmeath, that the following sums be levied upon and shall be collected from all ratable property in the Municipality of Westmeath for the year 1949,

a 1st That the sum of \$22.805.10 is hereby levied upon and shall be collected from all ratable property in the Township of Westmeath for County purposes for the year 1949 at a rate of 12.6 mills on the dollar,

- 2nd That the sum of \$ 1,328,94is hereby levied upon and shall be collected from all ratable property within the Township of Westmeath(excepting those in school sections no's 2-7-8-9-11) for County Pupils for the year 1949 at a rate of 1.3 on the \$2
 - 3rd That the sum of 9.099.61.is hereby levied upon and shall be collected from all ratable property within the Township of Westmeath for Township Purposes for the year 1949 at a rate of 5mills on the dollar,
 - 4th that the sum of \$9.428.25 is hereby levied upon and shall be collected from all ratable property of Public School Supporters in the Township of Westmeath for General School Purposes for the year 1949 at a rate of 5.4.mills on the dollar.
 - 5th that the sum of \$11.647.50.is hereby levied upon and shall be collected from all ratable property within the Township of Westmeath for ROAD Purposes for the year 1949 at a rate of 6.4 mil mills on the dollar.
 - 6th That the sum of \$ 320.90 is hereby levied upon and shall be collected from all ratable property within an area known as a lighting area for the Hamlet of Beachburg, for the year 1949 for the purpos se of street lights at a rate of 2./ mills on the dollar.
 - 7th That the sum of \$156.56 is hereby levied upon and shall be collected from all ratable property within an area known as a lighting area for the hamlet of Westmeath for the year 1949 for the purpose of Street Lights at a rate of 2.5 mills on the dollar
 - 8th That the sum of \$ 1.817.54 is hereby levied upon and shall be collected from all ratable property within School Sections No 8-11 for the purpose of Renfrew - Cobden and District High School Board at a rate of 6.4 mills on the dollar.

9th That the sum of \$ 403.79 is hereby levied upon and shall be collem cted from all ratable property within School Section no 9 for the purpose of Pembroke District High School Board at a rate of 5.4 mills on the dollar for the year 1949
