By-Law No. 612..... of the Corporation of the Township of
Westmeath..... setting apart the Township School
Area of.....

WHEREAS it is expedient that a township school area be set
apart:

THEREFORE the Council of the Township of Westmeath.....
pursuant to the authority conferred by subsection (1) of Section 15
of The Public Schools Act, R.S.O. 1937, chapter 357, enacts as fol-
lows:-

1. The portion of the Township described in section 2 hereof
is hereby set apart as a township school area.
