

A By-Law to assess and levy rates and taxes for County, Township, Roads, Street Lights, Schools, Grants, and all other purposes for the year 1950;-

Whereas it is necessary and expedient to provide by By-Law for the purpose of assessing and levying rates and taxes for the year 1950, for the following purposes,

Therefore the Municipal Council of the Corporation of the Township of Westmeath, hereby enacts as follows, that the following sums be levied upon and shall be collected from all ratable property in the Municipality of Westmeath for the year 1950.

- 1st That the sum of \$22,805.10 is hereby levied upon and shall be collected from all ratable property in the Township of Westmeath for county purposes for the year 1950 at a rate of 12.5 mills on the dollar.
- 2nd That the sum of \$1,416.60 is hereby levied upon and shall be collected from all ratable property within the Township of Westmeath (excepting those in School Section's No's (2.7.8.9.11)) for County Pupils for the year 1950 at a rate of .1.4 mills on the dollar.
- 3rd That the sum of \$10,974.73 is hereby levied upon and shall be collected from all ratable property within the Township of Westmeath for Township Purposes for the year 1950 at a rate of 6 mills on the dollar.
- 4th That the sum of \$ 8,912.91 is hereby levied upon and shall be collected from all ratable property of Public School Supporters in the Township of Westmeath for General School Purposes for the year 1950 at a rate of 5.2 mills on the dollar.
- 5th That the sum of \$11,706.38 is hereby levied upon and shall be collected from all ratable property within the Township of Westmeath for Road purposes for the year 1950 at a rate of .6.4 mills on the dollar.
- 6th That the sum of \$320.90 is hereby levied upon and shall be collected from all ratable property within an area known as a lighting for the Hamlet of Beachburg, for the year 1950 for the purpose of Street Lights at a rate of 2.1 mills on the dollar.
- 7th That the sum of \$ 156.56 is hereby levied upon and shall be collected from all ratable property within an area known as a lighting area for the Hamlet of Westmeath for the year 1950 for the purpose of Street Lighting, at a rate of 2.5 mills on the dollar.
- 8th That the sum of \$ 1,648.31 is hereby levied upon and shall be collected from all ratable property within School Sections No's 8 & 11. for the purpose of Renfrew- Cobden and District High School Board at a rate of 5.8 mills on the dollar. for the year 1950.
- 9th That the sum of \$572.69 is hereby levied upon and shall be collected from all ratable property within School Section No 9 for the purpose of Pembroke District High School Board at a rate of 7.7 mills on the dollar, for the year 1950.

and be it further enacted that the following rates on the dollar shall be levied upon and shall be collected from all ratable property in the Township of Westmeath included within the limits of the several School Sections hereinafter mentioned for the year 1950
