Whereas it is necessary and expedient to provide by By-Lawfor the purpose of assessing and levying Rates and Taxes, for the year 1951 for the following purposes,

Therefore the Municipal Council of the Corporation of the Township of Westmeath, hereby enacts as follows, that the following sums be levied upon, and shall be collected from all ratable property in the Municipality of Westmeath for the year 1951.

- lst That the sum of (\$26.612.86) is hereby levied upon and shall be collected from all ratable property in the Township of Westmeath, for County purposes for the year 1951 at a rate of .10.5 mills on the dollar.
- 2 That the sum of (\$2.182.84 dollarsis hereby levied upon and shall be collected from all ratable property within the Township of Westmeath (excepting those in School Sections No's(2.7.8.9.11) for County Pupils, for the year 1951, at a rate of (1.6) mills on the dollar.
- 3 That the sum of (\$ 10.216.73) is hereby levied upon and shall be collected from all ratable property within the Township of Westmeath for Township purposes, for the year 1951 at a rate of (4) mills on the dollar.
- 4 That the sum of \$9.100) is hereby levied upon and shall be collected from all ratable property of Public School Supporters in the Township of Westmeath for General School Purposes for the year 1951 at a rate of (3.8) mills on the dollar.

- 7 That the sum of (\$226.50) is hereby levied and shall be collected from all ratable property within an area known as a Lighting Area for the Hamlet of Westmeath, for the year 1951 for the purpose of St Street Lighting, at a rate of (\$2.1) mills on the dollar.
- 8 That the sum of (\$1735.66) is hereby levied upon and shall be collected from all ratable property within School Section's No (8.11) for the purpose of Cobden and District High School Board at a rate of (4.3) mills on the dollar. for the year 1951.
- 9 That the sum of (\$326.20) is hereby levied and shall be collected from all ratable property within School Section No(9) for the purpose of Pembrok and District High School Board at a rate of (3.1) mills on the dollar, for the year 1951.
