| defined an area to be known as "The Beachburg Water ARea" and |
| has provided that the cost of the work, including debenture |
| charges and the cost of maintenance and management of the work, |
| shall be assessed and levied on the rateable property of the |
| said area; and |
| WHEREAS it is expedient to grant the prayer of |

and that the cost of the work, together with the cost of maintenance and management thereof, shall be assessed and levied on all the rateable property in "The Beachburg Water Area!"

- 2. THAT the Engineer do forthwith make such plans, profiles and specifications and furnish such information as may be necessary for the carrying on of the work.
- 3. THAT the work be carried on under the supervision of such Engineer.
- 4. THAT the Reeve and Clerk are authorized to cause a contract for the construction of the work to be made and entered into with some person or persons, firm or corporation, subject to approval of the Council to be declared by resolution, unless the Council decides by resolution to carry on the work by day labor.
- 5. THAT the Treasurer may, subject to the approval by Council, agree with any bank or person for temporary advances of money to meet the cost of the work pending its completion.
- 6. THAT the debentures to be issued to cover the cost of the work when completed shall bear interest at such rate as the Council may determine, and be made payable within twenty years on the instalment plan.
