

A BY-LAW to ASSESS and Levy Rates And Taxes for County, Township, Roads, Street Lights, Schools, Grants, and all other purposes for the Year 1954, for the Township of Westmeath.

Whereas it is necessary and expedient to provide by By-law, for the purpose of assessing and levying Rates and Taxes for the year 1954 for the following purposes.

Therefore the Municipal Council of the Corporation of the Township of Westmeath hereby enacts as follows, that the following sums be levied upon and shall be collected from all ratable property in the Municipality of Westmeath for the year 1954.

- (1) That the sum of \$(28.647.56) is hereby levied upon and shall be collected from all ratable property in the Township of Westmeath for County purposes, for the year 1954, at a rate of (11.3) mills on the dollar.
- (2) That the sum of (\$4.361.20) is hereby levied upon and shall be collected from all ratable property within the Township of Westmeath, excepting those in School Sections No 1-2-3-4-5-8-9-10-11 & no 15 public, for County Pupils for the year 1954, at a rate of 3.9 Mills on the dollar.
- (3) That the sum of (\$7.647.45) is hereby levied and shall be collected from all ratable property within the Township of Westmeath, at a rate of (3 Mills on the dollar, for Township purposes, for the year 1954.
- (4) That the sum of (\$9.700) is hereby levied upon and shall be collected from all ratable property of Public School Supporters in the Township of Westmeath, for General School purposes for the year 1954 at a rate of (4.1) Mills on the dollar.
- (5) That the sum of (\$ 13.765.42) is hereby levied upon and shall be collected from all ratable property within the Township of Westmeath, for Road purposes for the year 1954, at a rate of (5.4) Mills on the dollar.
- (6) That the sum of (\$446.69) is hereby levied and shall be collected from all ratable property within an Area known as the lighting area for the Hamlet of Beachburg, for the purpose of street Lighting for the year 1954, at a rate of (1.5) Mills on the dollar.
- (7) That the sum of \$(226.38) is hereby levied upon and shall be collected from all ratable property within an Area known as the Lighting area for the Hamlet of Westmeath, for the purpose of Street Lighting for the year 1954, at a rate of (2.1) mills on the dollar.
- (8) That the sum of (\$173.15) is hereby levied upon and shall be collected from all ratable property within an area known as the Lighting area for the Hamlet of LaPasse, for the purpose of Street Lighting for the year 1954, at a rate of (5) mills on the dollar.
- (9) That the sum of (\$4.992.82) is hereby levied and shall be collected from all ratable property within Public School Sections No's 8-10-11 & 15 for the purpose of Cobden And District High School Board, for the year 1954, at a rate of (9.3) mills on the dollar.
- (10) That the sum of (\$637.69) is hereby levied and shall be collected from all ratable property within Public School Sections No's 8-10-11 and 15, for the purpose of Cobden and District High School Board Debenture, for the year 1954, at a rate, of (1.3) Mills on the dollar.
- (11) That the sum of (\$8.217) is hereby levied upon and shall be collected from all ratable property within Public School Sections No's ~~1-2-3-4-5-7-9-12-14~~ 1-2-3-4-5-7-9-12-14, for the purpose of Pembroke and District High School Board for the year 1954, at a rate of (5) Mills on the dollar.

And be it further enacted that the following rates on the dollar shall be levied upon and collected from all ratable property in the Township of Westmeath, included within the limits of the several School Sections hereinafter mentioned for Trustee Levy for the year 1954.
