Re: Supplementary Road Expenditure

By-law No. 1046 Amount - \$ 15,000

Please be advised that the above cited by-law has received consideration as a charge against the allotment for Special Capital Projects in the Department's estimates for the current fiscal year.

The Honourable Fred. M. Cass, Minister of Highways, has approved of the proposed expenditure, for subsidy purposes, to a limit of

\$ 15,000

for Construction,

SUBJECT TO THE FOLLOWING CONDITIONS:

- 1. That the expenditure(s) shall be made only for the purposes set out in the by-law and supporting programme and shall not be diverted, either in whole or in part, to any other purpose without the prior consent in writing of the Municipal Engineer.
- 2. That the individual works of road and bridge construction and the purchase of each unit of equipment and the award of contracts for same shall be subject to the approval of an engineer of the Municipal Roads Branch.
- 3. That the District Municipal Engineer shall be informed and his consent obtained before tenders are called for the proposed work or purchase and before any commitment is made by the Municipality.
- N. B. In the event that any portion of the cost of the proposed work or purchase is to be raised in a subsequent year or financed by the issue of debentures, the approval of the Ontario Municipal Board must be obtained before the work or purchase is authorized or any commitment made with respect thereto.

A copy of the by-law as approved is returned herewith.
