	Whereas it is necessary and expedient to provide by By-Law.for the purpose of assessing and Levying Rates and Taxes for the year 1962 for the following purposes.
	Therefore the Municipal Council of the Corporation of the Town- ship of Westmeath hereby enacts as follows, that the following sums shall be levied upon and collected from all Rateable property within the Municipality of Westmeath for the year 1962.

(2)	That the sum of (\$1264.76) is hereby levied upon and shall be collected from all rateable property. within the Township of Westmeath excepting those in School Sections No.1-2-3-4-5-7-8-9-10-11-12-14& 15. Public and NO 2 Seperate, for County Pupils for the year 1962 at a rate of (3.7) Mills on the Dollar.
	That the sum of (28.68334) is hereby levied upon and shall be collected from all rateable property within the township of West-meath, for General purposes (Roads & Township) for the year 1962 at a rate of (15.0) for Commercial, and (12.0) Mills for Residental on the Dollar.
	That the sum of (\$440.15) is hereby levied upon and shall be collected from all rateable property within an Area known as the lighting Area for the Hamlet of Westmeath, for the purpose of Street Lighting for the year 1962, at a rate of (3.8) Mills on the Dollar.
	That the sum of (\$189.20) is hereby levied upon and shall be collected from all ratable property within an Area known as the lighting Area for the Hamlet of Lapasse, for the purpose of Street lighting for the year 1962, at a rate of (5.6) Mills on the Dollar.
	that the sum of (\$10,061,56) is hereby levied upon and shall be collected from all rateable property within the Public School Sections of No.8-10-11 and 15, for the purpose of Cobden and District High School (Levy & Debenture) for the year 1962, at a rate of (17.6) Mills on the Dollar.
(7)	That the sum of (\$22,737,84) is hereby levied upon and shall be collected from all rateable property within the Public Sclool SectionsNo. 1-2-3-4-5-7-9-12 and 14, and Seperate School Section no 2, for the purpose of Pembroke and District High School Beard for the year 1962, at a rate of (16.3) Mills on the Dollar.
(_8_)_	And be it furthur enacted that the following rates on the dollar shall be levied upon and collected from all rateable property within the Township of Westmeath included within the limits of the several School Sections hereinafter mentioned for Trustee Levy for the year 1962.
