BY LAW NO. 64-34

A BY LAW TO AUTHORIZE THE JOINING IN AND
EXPENDITURE OF FUNDS FOR THE CONSTRUCTION
OF A COMMUNITY CENTRE IN THE VILLAGE OF
BEACHBURG

WHEREAS the Corporation of the Township of Westmeath desires to join in a project with the Corporation of the Village of Beachburg and apply part of its per capita grant under the terms of the Confederations Centennial Act 1962-63 to be used in the construction of a Community Centre.

AND WHEREAS IT IS AGREED THAT it is desirable to build and construct a Community Centre adjacent to the North Renfrew Agricultural Coliseum in the Town of Beachburg.

AND WHEREAS the Ontario Municipal Act, Section 377, Subsection 69 provides that the Municipal Councils may make expenditures or grants towards the construction of Community Centres and it is agreed that it is desirable to make such a grant.

NOW THEREFORE the Corporation of the said Township of Westmeath enacts as follows:

1. The Corporation shall assist the Village of Beachburg in the construction of a Community Centre adjacent to the North Renfrew Agricultural Society Coliseum at an estimated cost of Sixteen thousand (\$16,000.00) dollars by; applying a portion of its per capita grant namely Fifteen hundred dollars (\$1,500.00) toward the capital cost of the Centennial Project, and by granting as a municipal share of the project the sum of Fifteen hundred (\$1,500.00) dollars to the Corporation of the Village of Beachburg to be applied towards the cost of the project as follows: namely the sum of Five

hundred (\$500.00) dollars in each of the years 1964, 1965 and 1966 to be paid from current revenues.

2. The Mayor and the Clerk be and they are hereby authorized and directed to make application pursuant to the provisions of the regulations made under the Confederation Centennial Act 1962 for a grant in aid of the project.

3. This By-Law shall not take effect until the approval of the Ontario Municipal Board under Section 641 of the Ontario Municipal Board Act has been obtained.
