A BY-LAW TO AUTHORIZE THE REEVE AND CLERK TO EXECUTE AN AGREEMENT WITH THE VILLAGE OF COBDEN RELATIVE TO A CENTENNIAL PROJECT IN COBDEN

WHEREAS the Township of Westmeath has agreed to give the Village of Cobden a part of its per capita grant under the Centennial Projects Act.

AND WEREAS it is deemed advisable to enter into an Agreement with the Village of Cobden for this purpose.

THEREFORE the Council of the Corporation of the Township of Westmeath enacts as follows:-

- 1) The Reeve and Clerk be and they are hereby authorized to execute an agreement between the Corporation of the Township of Westmeath and the Corporation of the Village of Cobden annexed hereto as Schedule "A" to this By-law.

THIS By-law shall come into force and take effect upon the final passing thereof.

OF THE SECOND PART

WHEREAS under and by virtue of a certain act entitled "An Act to provide for the Observance and Commemoration of the Centennial of the Confederation in Canada", Statutes of Ontario, 1962-1963, Ch. 19, a municipality may make expenditures for, or grants toward the observance of the Centennial, and may enter into agreement with any one or more municipalities with respect to the same.

AND WHEREAS it is provided by the regulations passed under the said Act that Ontario shall make a grant towards such a project based on population.

AND WHEREAS Cobden proposes a project within the Village of Cobden pursuant to said Statute and regulations and Westmeath for such project has agreed that part of its population shall be made available and used for grant purposes with respect to such project.

THEREFORE this agreement witnesseth that in consideration of the premises and in the interest of the public welfare of both municipalities, it is agreed as follows:

1. That 1250 persons, part of the population of Westmeath, shall be included with the population of the Village of Cobden in establishing the population of Cobden for the purposes of an application by the Village of Cobden for provincial grants under the said Act and Regulations.

2. That Cobden shall designate, manage and do all things necessary or advisable to bring the said project to full fruition and completion.

3. That Westmeath shall have no responsibility or liability in anywise with respect to such contemplated project, either before or after the completion of same.

4. When the project is completed the full management, control and responsibility for upkeep and maintenance and all liability with respect to same shall belong exclusively to Cobden.

5. Each of the parties have duly enacted a by-law for the purpose of bringing this agreement into effect and for the due and proper execution hereof.
