THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

Being a by-law to adopt the estimates of all sums required during the year and to strike the rates of taxation for the year 1974.

Whereas the Council of the Township of Westmeath has in accordance with the Municipal Act considered the estimates of the municipality and of the Boards and Commissions of the municipality and it is necessary that the following sums be raised by means of taxation for the year 1974.

AND WHEREAS the Assessment Roll made in 1973 and upon which the 1974 taxes are to be levied was finally revised by the Assessment. Review Court.

AND WHEREAS the amount of Assessment entitled to benefit, hereinafter referred to as residential and farm, and the amount of assessment not entitled to benefit, hereinafter referred to as commercial and business, from Unconditional Grants in accordance with Sections 294 and 297 of The Municipal Act, is as follows:

AND WHEREAS the Assessment of each of the bodies for which it is necessary to levy rates is as follows:
