

THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

Being a by-law to adopt the estimates of all sums required during the year and to strike the rates of taxation for the year 1974.

Whereas the Council of the Township of Westmeath has in accordance with the Municipal Act considered the estimates of the municipality and of the Boards and Commissions of the municipality and it is necessary that the following sums be raised by means of taxation for the year 1974.

General Purposes	<u>\$107,825.00</u>
County Purposes	<u>\$ 31,922.00</u>
Public School	<u>\$ 59,332.00</u>
Separate School	<u>\$ 4,406.00</u>
Secondary School	<u>\$ 41,381.00</u>

AND WHEREAS the Assessment Roll made in 1973 and upon which the 1974 taxes are to be levied was finally revised by the Assessment Review Court.

AND WHEREAS the amount of Assessment entitled to benefit, hereinafter referred to as residential and farm, and the amount of assessment not entitled to benefit, hereinafter referred to as commercial and business, from Unconditional Grants in accordance with Sections 294 and 297 of The Municipal Act, is as follows:

Residential and Farm	<u>\$ 2,494,170</u>
Commercial and Business	<u>\$ 492,190</u>

AND WHEREAS the Assessment of each of the bodies for which it is necessary to levy rates is as follows:

AND WHEREAS the amount of the Unconditional Grant is \$11,700 which is the equivalent of 4.36 mills on the Assessment to benefit.

THEREFORE the Council of the Corporation of the Township of Westmeath ENACTS AS FOLLOWS

1. That the estimates be adopted and the following amounts be levied therefore in the manner as set out hereinafter--

Separate School	<u>\$ 4,406.00</u>
Secondary School	<u>\$ 41,381.00</u>
County	<u>\$ 31,922.00</u>

2. There shall be levied and collected upon the assessable lands, buildings and businesses within the Corporation of the Township of Westmeath the following rates for the year 1974.
