Where a resident of the hostel claims to be a person in need, in accordance with the provisions of The General Welfare Assistance Act, or the regulations thereunder, the Township of Westmeath Social Services shall determine the need, and assistance shall be paid by the Township of Westmeath Social Services for needy persons such that the combined payment of the resident and the Township of Westmeath shall be Eleven Dollars (\$11.00) per day. This amount will be payable to the Bernadette McCann House for Women

- A monthly statement of accounts shall be submitted by the Bernadette McCann House for Women Inc. for those persons eligible for General Welfare Assistance determined by the Township of Westmeath Social Services. These accounts shall be submitted within ten (10) days after the end of each month.
- This Agreement shall be subject to the approval of the Director, Municipal Welfare Consulting Branch, Ministry of Community and Social Services of the Province of Ontario.
- 7. This Agreement shall be binding upon the parties hereto on the day of execution and shall continue in force until the 30° day of $NW/60^{\circ}$
