WHEREAS the Corporation of the Township of Westmeath believes it to be in the public's interest to receive a conveyance of Part 4 Plan 49 3712 being part of Lot 16 Concession B. C.L.F. in the Township of Westmeath in the County of Renfrew for road purposes;

AND WHEREAS the Corporation of the Township of Westmeath believes it to be in the public's interest to transfer Part 2, Plan 49R3712 being part of the road allowance between Lot 30 W.F.E. and Lot 16, Con. B. C.L.F. Township of Westmeath in the County of Renfrew to Leo H. Gervais.

NOW THEREFORE the Council of the Corporation of the Township of Westmeath, enacts as follows:-


1. THAT Part 4 be exchanged for Part 2 in consideration of Leo H. Gervais paying all legal costs.

READ a third time and passed this 3 day of January 1979



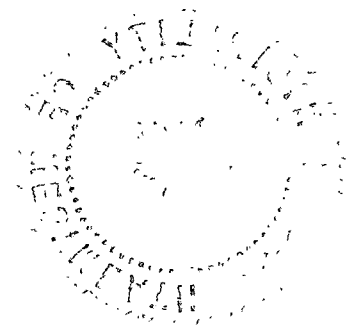
