

A BY-LAW TO ESTABLISH A COMMUNITY RECREATION
CENTRE AT THE HAMLET OF WESTMEATH

Whereas the Community Recreation Centres Act 1974 provides in Section 2 (1) that the Council of any municipality may by by-law provide for the establishment of a Community Recreation Centre in Accordance with the said Act and may acquire by purchase, lease or otherwise real and personal property for that purpose.

And whereas the Corporation of the Municipality of Westmeath is desirous of establishing a community Recreation Centre at Westmeath hamlet in the Township of Westmeath.

Therefore the Council of the Corporation of Westmeath enacts as follows.

1. That a Community Recreation Centre defined as a community hall be established and operated by the Corporation pursuant to the provisions of the Community Recreation Centres Act 1974.
2. That the said Community Recreation Centre be administered by a Committee of Management appointed pursuant to the provisions of the Community Recreation Centres Act and regulations thereunder which committee shall be composed as follows:
