- 1. SECTION 1 TITLE AND COMPONENTS is hereby modified by adding the words "and Schedule A" between the words "text" and "shall" in the first line.
- 2. SECTION 4 DETAILS OF THE AMENDMENT is hereby modified by deleting it in its entirety and replacing it with the following:
 - "1. Schedule 'A' MAP 1 is hereby amended by adding the words "SEE SECTION 7(1)(b)(i)" to those lands described as comprising Part of Lot 12, Concession III EML, in accordance with Schedule 'A' attached hereto.
 - 2. Section 7(1)(b) of the Official Plan is hereby amended by adding the following as Section 7(1)(b)(i)
 - 7(1)(b)(i) Notwithstanding Section
 7(1)(b), a bus transportation
 business may be permitted on
 those lands situated in Part
 of Lot 12, Concession III EML."

3. This amendment is hereby modified by the addition of Schedule entitled "Schedule A to Amendment 4".

As thus modified, this Official Plan Amendment is hereby approved pursuant to Section 21 of the Planning Act.

SECTION 1 - TITLE AND COMPONENTS

NO. _______ UNDER SECTION 17(9) OF

THE PLANNING ACT 1983
This Amendment, consisting of the following text, shall be known as
Amendment #4 to the Official Plan of the Township of Westmeath.

SECTION 2 - PURPOSE OF THE AMENDMENT

The purpose of this Amendment is to add a policy allowing a commercial bus transportation business to locate on a lot in part of Lot 12, Concession III EML.

SECTION 3 - BASIS OF THE AMENDMENT

The owners of a residential lot in part of Lot 12, Concession III EML want to expand their bus transportation business onto an abutting one-half acre of land which they intend to purchase. Consent for the proposed lot addition would not be granted by the Land Division Committee because the subject property was designated Agriculture.

Section 7(1)(b) of the Official Plan normally only allows businesses oriented to agriculture, a criterion which the proposed business would not meet.

Because of the small scale of the proposed use and its minimal impact on agricultural land, Council feels it appropriate to make a change to the policies affecting this parcel of land.

Correspondence from the Ministry of Agriculture and Food, County Engineer and County Health Unit support this consent application and therefore this change in policy.

SECTION 4 - DETAILS OF THE AMENDMENT

Section-7(1)(b)-of-the-Official-Plan-of-the-Township-of-Westmeath-is-amended by adding the following new subsection:

"(i) Notwithstanding the above-noted policy, a bus transportation business may be permitted in part of Lot 12, Concession-LLI, EML."

SECTION 5 - IMPLEMENTATION

The provisions of the Official Plan as amended from time to time, regarding implementation, shall apply to this Amendment.

SECTION 6 - INTERPRETATION

The policies of the Official Plan as amended from time to time, regarding interpretation, shall apply to this Amendment.
