

THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

BY-LAW NO. 86-08

Being a by-law to adopt the estimates of all sums required during the year, and to set the rates of taxation for the year 1986.

Whereas the Council of the Township of Westmeath has, in accordance with the Municipal Act, considered the estimates of the Municipality, and has determined that it is necessary to raise the following sums by taxation in 1986:-

And whereas the Assessment Roll made in 1985 for taxation in 1986, as revised, shows the following assessments for the bodies concerned:-

| Public              | 2,663,230              | 95,672                  |
| Separate            | 629,665                | 24,730                  |

| Westmeath S.L. Area | 170,335                | 5,790                   |
| Lapasse S.L. Area   | 50,140                 | 3,375                   |

Therefore the Council of the Township of Westmeath enacts as follows:-

1. That the estimates be adopted and the above mentioned amounts be levied in the manner set out hereinafter.
2. That there shall be levied and collected upon the assessment of the lands, buildings and businesses within the Corporation the following rates for 1986:-

3. That 1986 taxes will be payable in three instalments. The interim bill having been due March 31st 1986, the second and final instalments will be due July 31st and November 28th 1986.
4. That this by-law shall come into effect upon the date of final reading.
