A BY-LAW TO AUTHORIZE THE SALE OF PART OF LOT 27 CONCESSION "B" EAST OF MUSKRAT LAKE, TOWNSHIP OF WESTMEATH, COUNTY OF RENFREW TO TIMMINCO LIMITED - TIMMINCO LIMITED

WHEREAS the Corporation of the Township of Westmeath purchased the lands herein referred to in a Tax sale to preserve the property from deterioration for the purpose of resale.

AND WHEREAS the Council of the Corporation of the Township of Westmeath believes it to be in the best interests of the public to re-sell the property to the Purchaser herein referred to.

NOW THEREFORE the Council of the Corporation of the Township of Westmeath ENACTS AS FOLLOWS:-

1. THAT the parcel of land described in Schedule "A" hereto attached be sold for the sum of Three hundred and twentythree thousand, four hundred and seventy-eight dollars ( $\$ 323,478.00 L$ to TIMMINCO LIMITED - TIMMINCO LIMITEE
2. THAT the Reeve and Clerk of the Corporation of the Township of Westmeath be authorized to execute whatever documents are necessary in order to effect such transfer.

ALL and Singular that certain parcel or tract of land and premises, situáte, lying and being in the Township of Nestmeath, in the County of Renfrew, in the Province of Ontario and being composed of part of Lot 27, Concession "B", East of Nuskrat Lake of the sald Township of Westmeath and containing therein by admeasurement an area of 25.68 acres be the same more or less and which said parcel or tract of land may be more particularly described as follows:

COMAENCING at a survey post planted in the north-eastern limit of the King's Highway No. 17 through said Lot 27 , said post being distant $34-4-4$ feet measured North 40 degrees 44 minutes West along the said norifheastern 1 imit from a point therein distant 0.53 feet measured North 40 degrees 49 minutes West and continuing along the said north-eastern 1 imit of the King's llighway No. 17 from its intersection with the 1 imit between Lots 26 and 27 , Concession "B", East of Muskrat Lake, said intersection being distant 17 feet measured North 49 degrees 50 minutes 30 seconds East from the most southern corner of Lot 27, Concession "B", East of Muskrat Lake;
