- 2) This By-law will become effective on the date it is approved by the Ministry of Consumer and Commercial Relations.


#### SCHEDULE "A" TO BY-LAW 86-17 PAGE 1 OF 2

The Bethel Cemetery is enclosed with a good steel page-wire fence. Access is gained through a steel gate. The property bounded by the fence measures 30m x 50m approx., giving it an area of 1500 m<sup>2</sup>. The property is quite stony and uneven and there are nine small to medium size trees growing on it.

There are a total of eleven grave stones. Of these eleven , eight are fairly large and three are the smaller "tablet" type. In addition to these there are six small flat markers. Three of the graves have stone corner markers and two grave plots have steel rails surrounding them. There are obviously some unmarked graves.

Faced with the responsibility of maintaining the Bethel Cemetery as efficiently and economically as possible, the following recommendations are being put forward:

- 1. Remove all steel railings
- 2. Bury flush with ground level or remove all corner markers
- 3. Spread and seed clean fill over the whole area to allow for easy mowing.




