A BY-LAW TO AUTHORIZE THE EXECUTION OF AN AGREEMENT OF PURCHASE BETWEEN THE VILLAGE OF COBDEN, TOWNSHIP OF BROMLEY, TOWNSHIP OF WESTMEATH, TOWNSHIP OF ROSS --- FOR THE PURPOSE OF PURCHASING FIRE EQUIPMENT TO SERVICE VILLAGE OF COBDEN, TOWNSHIP OF BROMLEY, TOWNSHIP OF WESTMEATH AND THE TOWNSHIP OF ROSS.


WHEREAS the Municipal Council of the Township of Westmeath deems it necessary to purchase fire equipment for the purpose of fire protection for the Townships of -- Village of Cobden, Township of Bromley, Township of Westmeath and Township of Ross.

NOW THEREFORE the Municipal Council of the Corporation of the Township of Westmeath enacts as follows:-

1. That the Reeve and Clerk be hereby authorized to execute the document attached hereto and marked as Schedule "A" to this by-law and affix thereto the Corporate Seal.
2. This by-law shall be into force and take effect upon the date of final passing thereof.

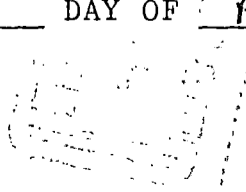
