THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

BY-LAW NUMBER 89-24

A By-law to amend By-law Number 81-9

WHEREAS By-law No. 81-9 regulates the use of lands and the erection, location and use of buildings and structures within the Township of Westmeath;

AND WHEREAS Council deems it appropriate to further amend By-law No. 81-9;

NOW THEREFORE the Council of the Corporation of the Township of Westmeath amends By-law No. 81-9 as follows;

- Section 2, DEFINITIONS, is amended by adding the following new 1. subsections:
 - (67A) "Group Home" means a single housekeeping unit in a residential dwelling in which up to three persons (excluding supervisory staff or the receiving family) live as a family under responsible supervision consistent with the particular requirements of its residents. The home is licensed and/or approved under provincial statutes and in compliance with municipal by-laws. A "Group Home" shall not include a facility where the residents are ordered to attend at such facility, whether pursuant to the Criminal Code of Canada or the Young Offenders Act.

(67B) <u>GROUP HOME CORRECTIONAL</u> "Correctional Group Home" means a group home which houses persons sentenced by a court to serve time in such facility and may include:

Halfway Houses for Ex-Offenders (Ministry of Community and Social Services-Charitable Institutions Act);

<u>Community Resource Centres</u> (Ministry of Correctional Services-Ministry of Correctional Services Act);

Group Homes for Young Offenders (Ministry of Correctional Services of Ministry of Community and Social Services -Young Offenders Act).

- 2. Section 3, GENERAL PROVISIONS, is amended by adding the following new subsection:
 - "(27) GROUP HOMES

No group home shall be permitted within 8km of another group home, whether such group home is located in the Township of Westmeath or not. A maximum of four group homes may be located in the Township of Westmeath."

- Section 5(1)(a), 6(1)(a), 11(1)(a), 16(1)(a) and 17(1)(a) are amended by adding a "group home, but not a correctional group home" to the lists of permitted residential uses. 3.
- 4. Section 11, INSTITUTIONAL ZONE, is amended by adding the following new subsection:
 - "(3) SPECIAL EXCEPTIONS

(a) I-1: Notwithstanding any provision of section 11(1) to the contrary, on the lands identified as Institutional, Special Exception One (I-1), a correctional group home shall be permitted."

This By-law shall become effective on the date of passing hereof.
