THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

BY-LAW # 90-09

A By-Law to stop up and sell to the Adjoining Owners part of Victoria Street in the Hamlet of Westmeath.

WHEREAS: <u>1</u> Parts 1, 2, 3, 4, 5 and 6 on RP49R9610 are part of Victoria Street and lots 46, 47 and 48 as laid out in Plan 45 of the Township of Westmeath

> 2 The Council of the Corporation of the Township of Westmeath has authority under Section 298(1) (c) and (d) of the Municipal Act RSO 1980 Chapter 302 to stop up and sell part of a highway.

<u>3</u> The Council of the Corporation of the Township of Westmeath deems it advisable to stop up and sell part of Victoria Street and lots 46, 47 and 48 on Plan 45 of the Hamlet of Westmeath, more particularly described as parts 1, 2, 3, 4, 5 and 6 on RP49R-9610 to the adjoining land owners.

NOW THEREFORE the Council of the Corporation of the Township of Westmeath ENACTS as follows:

- 1) That parts 1, 2, 3, 4, 5 and 6 on Reference Plan 49R-9610 are hereby closed, and are no longer part of a public highway.
- 2) That the Reeve and Clerk are authorised to execute such documents as are necessary to sell the said lands to the adjoining owners for two dollars per owner and the surveying, legal and other associated costs of dividing the land.
- 3) That after this By-Law is read a first and second time the Clerk will notify the Corporation of the County of Renfrew by registered mail or personal service, of the intention of the Council of the Township of Westmeath to give final reading of this By-Law immediately after the expiration of sixty (60) days of the receipt by the Clerk of the County, or sooner, if the County enacts a by-law consenting to the passing of this by-law, as provided for in Section 298, subsection 9(a) of the Municipal Act.
- 4) That the Clerk is authorised to make the necessary arrangements for publication of the provisions of this by-law, pursuant to Section 301(1) of the Municipal Act. Such publication will be made after second reading of the by-law, and will indicate that third reading will be given after the sixty (60) days period referred to in item 3) above, has elapsed.
- 5) That this by-law shall not come into force and take effect until the date of the final passing; and until the sixty (60) day period referred to in item 3) above has elapsed and no Notice of Objection has been received from the County of Renfrew, or the County has enacted a by-law as described in item 3) above; and until the by-law has been registered in the Registry Office for the Registry Division of Renfrew 49.
