

THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

BY-LAW # 92-23

A By-Law to enter into a contract for telephone answering and radio dispatching service.

WHEREAS:

- 1 The Municipality has authority under this section 102, Chapter M. 45 of the Municipal Act R.S.O. 1990 to make provision for the welfare and safety of the inhabitants of the Municipality.
- 2 The Council of the Corporation of the Township of Westmeath considers it desirable to supply the fire department with a telephone answering and radio dispatching service.


NOW THEREFORE the Municipal Council of the Corporation of the Township of Westmeath ENACTS as follows:-

- 1) That the Corporation of the Township of Westmeath enters into an agreement, known as Schedule 'A' attached to, and forming part of this By-Law with Davis Communications for supplying the Westmeath Fire Department with telephone answering and radio dispatching service.
- 2) The Clerk is hereby authorized to sign the agreement referred to in Section 1 on behalf of the Corporation.

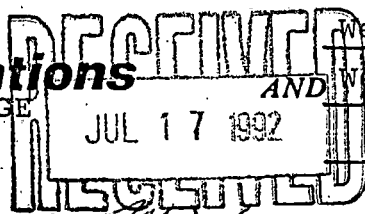

1997. However, this may be terminated by either party on written notice. (30 days)

The following service will be rendered:

Telephone answering and radio dispatching 24 hours a day, 365 days a year. Recorded tapes and written messages to be kept and turned over to the Fire Department upon request.

Telephone answering & dispatching: \$229.65 per month
Dial-A-Page - 7 pagers: \$185.38 per month

Rate for this service is, per month (\$415.03) payable in advance per month.

Terms: 10 days net. ~~XXXXXXXXXXXXXXXXXXXXXXXXXXXXXXXXXXXX~~

Special agreements (or) arrangements:

A 10% discount on Telephone Answering, Dispatching and Paging Service upon receipt of full payment in advance.

No rate increase until 1993/1994 with a 5% increase each and every following year.

It is agreed and understood that the method of providing the above mentioned services is assigned completely to **Davis Communications**.

The above contract (without prejudice) comprises the entire agreement (or) understanding of any nature concerning same will be recognized.
